WAIVER OF LIABILITY; ASSUMPTION OF RISK: Parent acknowledges that the use of Onelife Fitness® facilities, equipment, services and programs involves an inherent risk of personal injury. Parent voluntarily agrees to assume all risks of personal injury to Guest and waives any and all claims or actions that Parent or Guest may have against this Onelife Fitness®, any Onelife Fitness®, any subsidiaries or other affiliates and any respective officers, directors, employees, agents, successors and assigns for any such personal injury (and no such person shall be liable to Parent, Parent's spouse, children, unborn children, other family members, guests or invitees for any such personal injury), including, without limitation (i) injuries arising from use of any exercise equipment, machines and tanning booths, (ii) injuries arising from participation in supervised or unsupervised activities and programs in exercise rooms, swimming pools, hot tubs, on running tracks, rock walls, courts or in other areas of any Onelife Fitness®, (iii) injuries or medical disorders resulting from exercising at any Onelife Fitness®, including heart attacks, strokes, heat stress, sprains, broken bones and torn or damaged muscles, ligaments or tendons and (iv) accidental injuries within and around Onelife Fitness® facilities, including locker rooms, steam rooms, whirlpools, hot tubs, spas, saunas, showers and dressing rooms. Member acknowledges that (x) Onelife Fitness® does not manufacture any of the fitness or other equipment at its facilities and (y) Onelife Fitness® does not manufacture any vitamins, food products, sports drinks, nutritional supplements or other products sold at its facilities; accordingly, neither this Onelife Fitness® or any Onelife Fitness® any subsidiaries or other affiliates nor any respective officers, directors, employees, agents, successors or assigns shall be held liable for any such defective equipment or products. Parent shall indemnify each of this Onelife Fitness®, any Onelife Fitness®, any subsidiaries or other affiliates and any respective officers, directors, employees, agents, successors and assigns (an "Indemnified Party") and save and hold each of them harmless against and pay on behalf of or reimburse any such Indemnified Party as and when incurred for any Losses which such Indemnified Party may suffer, sustain or become subject to, as a result of, in connection with, relating to or incidental to by virtue of any claim that is the subject of the waiver set forth above. The provisions of this paragraph shall survive the termination of the Guest's use of any Onelife Fitness facility.

You (the Parent of the Guest) are aware that your child is engaging in physical exercise and that the use of exercise equipment, club facilities, training and instruction, could cause injury to him/her. You are allowing your child to use the facilities at Onelife Fitness voluntarily and at your own risk and you shall hold harmless Onelife Fitness, its officers, employees, owners, representatives, affiliates and agents from any and all claims or potential claims, suits or potential suits, liability, damage or injury to you, your child or your property resulting from such use, whether known or unknown. You have carefully read this waiver which states that you assume all risks of injury to your child. You are hereby advised that people that engage in exercise activities should be sufficiently physically fit for these activities and should have consulted a physician prior to undertaking a physical exercise program.
